RULES OF THE CENTRE

Silesia City Center cares about the security of its Customers. Therefore, Customers are kindly requested to follow these Rules, which are applicable in the entire area of Silesia City Center in Katowice ("Silesia City Center" or the "Centre").

I. Communication

1. Customers are not allowed to park their cars in places designated for the disabled.
2. Blocking of fire safety routes and "no parking" areas is forbidden. All damage caused by mechanic vehicles parked outside of designated places will be remedied by the owner of the vehicle. Costs of towing a vehicle parked outside of a designated place will be paid by the owner of the vehicle.
3. Driving vehicles (including motorcycles, scooters or bicycles) alongside communications routes or in pedestrian areas or the parking lot is forbidden. Disturbing order and causing danger to traffic safety is forbidden.
4. Inline skating, skateboarding or kick scooting is forbidden. Customers are not allowed to ride bicycles inside the Centre. Bicycles may be taken inside the Centre only to be left with or collected from a bicycle service shop.
5. Visitors may sit on benches or in designated places only.

II. Use of trolleys

1. Using trolleys contrary to their designation is forbidden.

III. Promotion and marketing

- I. No advertising, distribution of flyers or presenting of advertising materials in any form is allowed without the prior consent of the Centre's Management.
- II. Holding meetings, offering goods for sale, conducting itinerant vending, making music and other performances or organizing charity auctions on the premises of the Centre without the prior consent of the Centre's management is forbidden.
- III. Begging or canvassing are forbidden.

IV. Animals

1. Dogs are allowed in the Centre. Dogs should be leashed and muzzled. Dogs' owners are obliged to remove all dog waste.

V. Found items

1. Found items must be deposited with the Centre's security officers or the employee of the Information Centre in Plac Śląski. Any retaining of found items constitutes a breach of the law.

VI. Weapons and prohibited substances

1. No weapons, explosives, narcotics, flammables or other substances causing danger to the lives and safety of Customers or property are allowed on the premises of Silesia City Center, unless they are allowed under other regulations.

VII. Tobacco and alcohol

1. Smoking tobacco products or the so-called electronic cigarettes or consuming alcoholic beverages outside of designated and specially marked places is forbidden.

VIII. No stay

1. Intoxicated persons disturbing public order, causing nuisance to others or persistently defaulting on these Rules are not allowed to stay on the premises of the Centre.
2. Staying on the premises of the Centre despite having been requested to leave them might be prosecuted.

IX. Illegal activities

1. Intentional fouling, damaging or using contrary to designation of any facilities in Silesia City Center, including facilities in areas accessible to the public such as toilets, sanitary rooms, etc., is forbidden. Damage caused by the above-mentioned activities will have to be remedied, and a person causing it will be denied access to Silesia City Centre.
2. Irrespective of the above-mentioned rules, no other, illegal activities are allowed in the Centre. The visitors of the Centre are kindly requested to respect all guidelines and orders given by the security officers and Management of the Centre.

The premises of Silesia City Center are monitored with the use of video cameras.
